What Does Abridge Partners, LLC, Do With Your Personal Information?

The <u>Law</u>

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share and protect your personal information. Please read this notice carefully to understand what we do.

Our Policy

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Income
- Employment and residential information
- Social security number
- Cash balance
- Security balances
- Transaction detail history
- Investment objectives, goals, and risk tolerance

When you are *no longer* a client, we continue to share your information as described in this notice.

Your Rights

All financial companies need to share customers' personal information to run their everyday business. We list below the reasons financial companies can share their customers' personal information; the reasons Abridge Partners chooses to share; and whether you can limit this sharing.

Definitions		
Everyday Business Purposes	The actions necessary by financial companies to run their business and manage customer accounts, such as providing investment advisory and financial planning advice, processing securities transactions, and otherwise providing financial services to you.	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. Abridge Partners has the following affiliates: • Birgen Asset Management, Inc. • Business Prosperity, LLC	
Non-Affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. Abridge Partners does not share information with non-affiliates for marketing purposes.	
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Abridge Partners does not engage in joint marketing with non-affiliates.
